PS: BLA Bylaw Revisions - Over the past several months, the BLA Board of Directors has looked at a number of initiatives to improve the way we operate. These have included examining the existing BLA bylaws and the consideration of changes to the bylaws to make them more compliant with the "best practices" used by other Maine non-profit organizations. The current BLA bylaws require all bylaw changes be made by the BLA membership. At its meeting on July 8, 2016, the BLA Board of Directors adopted a proposed set of revised bylaws. Among other changes, these proposed bylaws would empower the Board to make future changes to the bylaws. Of course, the membership would continue to elect the Board of Directors. These revised bylaws will be presented to the association membership for ratification at our annual meeting on Sunday, July 31<sup>st</sup>.
